### Both parties agree to the following terms:

The Seller JBQAV agrees to place on display the mutually agreed upon item(s) in a prominent area that is of JBQAV's place of business or booth at a display fair.

The Seller JBQAV is entitled to retain 20%/25%/30%/35% per 30/60/90/120 days respectively of the purchase price of each sale for such display.

The Seller JBQAV shall submit a check for the full amount of the purchase price, less the previously mentioned agreed upon % to the Consignee within 7 business days of receipt of the sale.

The Seller JBQAV agrees to obtain the price set by the consignee for each item sold, and will accept nothing less than the purchase price for the consigned merchandise unless otherwise agreed upon in writing or email, and signed off by both parties. All serious offers to be communicated between both parties by cell phone conversation can be followed up by a text agreement to sell items.

The Consignee agrees to leave merchandise with the Seller JBQAV for a maximum of 120 Days. All merchandise that is not sold at the end of the consignment time-frame will be evaluated by both the Seller JBQAV and Consignee. If the Consignee decides to remove their merchandise, the Consignee takes responsibility for any delivery costs that may result for such removal.

All marketing merchandise such as brochures, pamphlets, displays, etc., will be removed at the time the items are removed from the Seller's JBQAV store, unless otherwise mutually agreed upon by both the Seller JBQAV and Consignee.

The Seller JBQAV and Consignee do hereby agree to the terms set forth above by their signatures found below.
